Thank you for your purchase of the TORQ Full or Mini Spool by Torq-Masters Industries. Your TORQ Spool has limited lifetime warranty. Please refer to your Vehicle Manual for differential removal procedure.

BASIC INSTALL INSTRUCTIONS:

- 1.) Remove Front Differential from the vehicle
- 2.) Drain oil and open the differential housing
- 3.) Remove the 2 hubs. Leave the Sprague inside the ring gear for MINI SPOOL. Remove the Sprague for FULL SPOOL
- 4.) Use a Press to remove the bearing on each hub. Remove spacers from the stock hubs, if you have spacers, then place them on the Spool.
 - a. MINI SPOOL – Press 1 bearing on, then slip the Sprague over the spool, then press on the second bearing
 - b. FULL SPOOL – Press on bearings. Sprague is eliminated.
- 5.) Reassemble the differential, inspect cover o-ring and torque differential cover bolts to 11 ft/lbs in a star pattern.
- 6.) Reinstall differential into the vehicle and fill with gear oil

LIMITED LIFETIME WARRANTY

TORQ FULL & MINI SPOOL

Torq-Masters Industries Inc {TMII} will warranty TORQ Spool for the lifetime of the original customer. Proof of purchase is required to submit a warranty claim. All warranty claim TORQ Spools must be returned to TMII for consideration at the customer's expense. TMII will then process warranty and ship a replacement free of charge. The TORQ Spool warranty is non-transferrable.

This warranty excludes labor or consequential damages or injury. Any failure of the product as before described must be reported to Torq-Masters Industries Inc {TMII} within fifteen (15) days of failure, contact us for a Return Authorization Code and instructions. This warranty is in lieu of all other warranties express or implied and all other obligations or liabilities on the part of TMII. This warranty covers the original purchaser only. This warranty does not cover defects caused by any of the following: modification, alteration, repair or service of the product by anyone other than by the manufacturer or its authorized representative, physical abuse to or misuse of the product, improper diagnosis, improper installation, and road, offroad or accident damage.

TMII has no liability for incidental, consequential or special damages including, but not limited to, claims of personal injury or property damage and claims of liabilities by third parties not the original purchaser to the product.

If the purchaser disagrees with any of the terms of this warranty, please return the purchased item to Torq-Masters Industries, Inc. within five (5) business days of receiving shipment. Buyer is responsible for all shipping charges for receipt and return of product. A decision by the purchaser to retain the item purchased will be deemed acceptance of the specific terms of this warranty.
